Everyone around the world need to support this initiative opening their heart and purse strings!

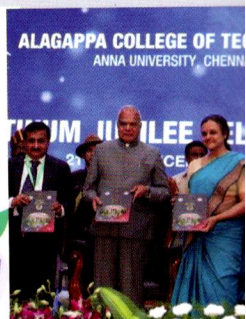
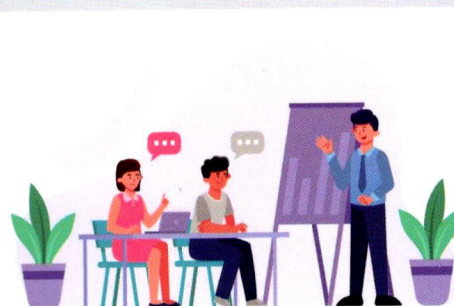

Both INR payment and US\$ payments will qualify for Tax exemption as per tax laws in India and USA respectively.

The funds will be maintained by ACTAA batch-wise or branch-wise or chapter-wise or Corporate-wise as preferred by the respective donors and utilization statement will be published annually. The students selected and sponsored by each group or individual will be published in the website. The donors will be provided the opportunity to interact with the respective scholars sponsored by them for providing additional guidance.
